#### **Description of Research and Scholarly or Creative Objectives**

I am a critical care nurse, family research scientist, and phenomenologist whose research advances patient- and family-centered care in intensive care units. My program of research focuses on optimizing family engagement during patient- and family-centered interdisciplinary rounds (PFCC-IR), mitigating psychological distress among families, and strengthening communication and shared decision-making. Using qualitative, quantitative, and sequential mixed-methods designs, I have generated foundational evidence demonstrating the benefits of family engagement and identifying modifiable organizational barriers in ICU workflows. My current objective is to develop and evaluate the Nurse-TECH-Family framework, a nurse-led, telehealth-enabled model informed by Family Systems Theory and Stress and Coping Theory to promote equitable virtual family participation, particularly in underserved and racially and ethnically diverse communities. Through this work, I aim to produce scalable, implementation-ready strategies that enhance communication equity, improve family well-being, and transform ICU practice.
